Transactions are processed through the same encrypted network trusted for payroll and tax refunds.

A \$200 invoice has an ACH fee under \$1, versus \$8.75 when using a credit card.

Breakdown of Your Fees

Growers have the option to participate in (1) general waste discharge requirements for irrigated lands through a third-party representative such as the Kings River Water Quality Coalition or (2) individual waste

discharge requirements for growers who are not part of a third-party group. Cost estimate comparisons between the Coalition's shared resources and individual permits follow:
